

Edgemont Community Association COVID-19 RULES AND Community Centre Declarations

This declaration must be completed prior to visiting *Edgemont Community Centre*. Failure to do so prior will result in denial of access to the *program you have signed up for*.

The *Edgemont Community Association* appreciates and expects your cooperation to allow us to re-open the *Community Centre*. We are asking that you strictly observe our rules during COVID-19. The *Edgemont Community Association* is permitting use based on your assurances within this document. Any false statements could result in legal liability towards you. You agree to observe and fully abide by all rules and regulations prescribed by the *Edgemont Community Association*. You may be asked to leave the premises if you are not following the rules and regulations prescribed by the *Edgemont Community Association*.

The virus can be transmitted by asymptomatic people. The *Edgemont Community Association* is following government rules and regulations but there can be no assurance that the virus will not be contracted at *the Community Centre*. Please understand that you are taking part in this program or activity at your own risk.

This waiver may be filled in advance providing on the day of the event or each time you attend a program with multiple dates the declaration below is correct. If on the day of the event or program you can no longer meet the declaration, please do not enter the facility.

I hereby declare that I or anyone in my household is not or has not been infected with the COVID-19 virus or has made a full recovery and subsequently tested negative for COVID-19.

This remains in effect during the entire COVID-19 pandemic unless communicated otherwise.

I hereby declare that I or any member of my household have not travelled to or had a lay-over in any country outside Canada in the past 14 days. If I or anyone in my household travel to any country outside Canada after submitting this declaration, I will then not visit *the Edgemont Community Centre* for a minimum period of 14 days after the date of return to Canada. * This remains in effect during the entire COVID-19 pandemic unless communicated otherwise.

I have read and understand the *Edgemont Community Association* COVID-19 rules and accept and waive any right to privileges should I not comply with these rules.
